As a participant of the 1st ANOC World Beach Games 2019 ("AWBG2019"), I acknowledge and agree that my participation in AWBG2019 is conditional upon my acceptance of and my compliance with all the provisions of this Eligibility Conditions Form and related rules referred to herein, which have been determined by the Association of National Olympic Committees ("ANOC") and the AWBG2019 Local Organizing Committee

For participants who are minors (under the age of 18) at the time of signing of this document, their participation in the AWBG2019 is further conditional upon the participant`s parents or legal guardian confirming their approval with the consent granted hereunder by the minor participant through the signature of the Parent/Legal Guardian Acknowledgement of Consent for Minors.

- 1. Capture and Use of Images: participants may be filmed and photographed, during AWBG2019. Understanding that as a participant at the AWBG2019, in consideration of the acceptance of my participation therein, I agree to be filmed, televised, photographed, identified and/or otherwise recorded during the AWBG2019, and that my captured or recorded images, together with my name, likeness, voice, performance and biographical information, may be used in any content, format and through any media or technology whether now existing or created in the future, by ANOC and third parties authorized by ANOC during and after the ANOC World Beach Games in perpetuity in relation to the celebration and promotion of the ANOC World Beach Games ("AWBG"), the Sports Movement and ANOC in a commercial or non-commercial manner.
- 2. Processing of personal information: AWBG2019 Local Organizing Committee, ANOC and the host country, host state, and host city may require access to certain information, in particular to ensure the security at the Games, manage accreditations, competitions and results, carry out anti-doping activities, prevent manipulation of competition results, and provide services for the participants and the media. I agree to personal information about me (personal data) being collected for the AWBG2019 being used and stored in any place required for the Games operations, for the purpose of facilitating my participation in, and/or organizing AWBG2019. This consent includes in particular the right for ANOC to collect and process my personal data, including when necessary, share such data with the host country, host state, and host city law enforcement authorities, the World Anti-Doping Organization, the Court of Arbitration for Sport and other third parties, in all manners and for the duration necessary for the following purposes:
 - a. Security risk assessments and other verifications to be carried out by the host country, host state, and host city authorities in order to grant accreditation for the AWBG2019;
 - b. Investigation and/or prosecution of breaches of any provisions referred to in paragraph 3;
 - c. Statistics, historical studies and other research projects conducted during and after AWBG2019;
 - d. Any other data processing operation to which I provide my express consent to AWBG2019 Local Organizing Committee.

I have taken note that I can contact ANOC in order to exercise my right to request access, rectification or deletion of my, or the participant`s, personal information.

- 3. Compliance with the provisions of the Olympic Charter applicable to the Olympic Games and other rules: participating in AWBG2019 is subject to the compliance with the fundamental rules governing the Olympic Movement, which aim to ensure the integrity of AWBG2019 and the protection of clean athletes. The provisions (Rules and their Bye-laws) of the Olympic Charter applicable to the Olympic Games apply, with necessary modification, to the AWBG2019. These provisions include, without limitation, Rule 40 (Conditions of Participation), Rule 41 (Nationality of Competitors), Rule 42 (Age Limit), Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Manipulation of Competitions), Rule 44 (Invitations and Entries), Rule 48 (Media Coverage), and Rule 50 (Advertising, Demonstrations, Propaganda). I confirm that I have full knowledge of the provisions applicable to my participation at AWBG2019 and that I agree to comply with all the rules and responsibilities applicable to my participation at AWBG2019, in particular those arising from the following:
 - a. The provisions of the Olympic Charter that apply, with necessary modification, to the AWBG2019 and, in particular, the provisions regarding Eligibility to participate in Games (including Rule 40 and its Bye-law), the mass media (Rule 48 and its Bye-law) and the prohibition on forms of publicity or propaganda on persons or on clothing and equipment worn or used at the Games (Rule 50 and its Bye-law);
 - b. The World Anti-doping Code, as well as the additional anti-doping regulations applicable for the AWBG2019;



- c. The Olympic Movement Code on the Manipulation of Competitions;
- d. The ANOC Code of Ethics.

I confirm that the above referred texts and all the rules, and responsibilities applicable to my participation at the AWBG2019, have been brought to my attention by my National Olympic Committee.

- 4. Acknowledge and acceptance of risks while participating at AWBG2019: participation may imply exposure to certain risks (i.e. injury, loss of property, death), which despite all care taken by ANOC and AWBG2019 Local Organizing Committee may not be completely eliminated. I agree to participate in the AWBG2019 at my own risk; that I will take all reasonable measures to protect myself from the risks of participation; that I am responsible for all property I bring into the AWBG2019 sites and that AWBG2019 Local Organizing and ANOC shall have no responsibility for any loss or damage to this property. To the fullest extent allowable under applicable laws, I irrevocably release AWBG2019 Local Organizing Committee and ANOC (and their respective members, directors, officers, employees, volunteers, contractors or agents) from any liability for any loss, injury or damage that I may suffer in relation to my participation in the AWBG2019, including death.
- 5. Arbitration: the Court of Arbitration for Sport is exclusively competent to finally settle all disputes arising in connection with my participation in the AWBG2019, which have not been resolved by sports governing bodies. I agree that any dispute or claim arising in connection with my participation at the AWBG2019, not resolved after exhaustion of the legal remedies established by my NOC, International Federation governing my sport, AWBG2019 Local Organizing Committee and ANOC, shall be submitted exclusively to the Court of Arbitration for Sports (CAS) for final and binding arbitration in accordance with the Code of Sports-related Arbitration. The seat of arbitration shall be in Lausanne, Switzerland and the language of the procedure English. The decision of CAS is final, binding and non-appealable, subject to the appeal to the Swiss Federal Court. I hereby waive my right to institute any claim, arbitration or litigation, or seek any other form of relief, in any other court or tribunal.
- 6. National Olympic Committee`s confirmation: the NOC hereby guarantees that all the relevant rules, including all those referred to above, have been brought to the attention of the participant and that the NOC has been authorized by the National Sports Federation concerned to sign this Eligibility Conditions Form on the latter`s behalf, with the approval of the relevant International Federation.
