
WORLD TAEKWONDO





All General Principles apply unless expressly mentioned otherwise hereafter (in particular in relation to size, frequency or location). Please refer to the "Identifications on NOC Team Apparel Practical Guidelines", and General Guidelines (released Summer 2023) to obtain the general principles of Authorised Identifications on NOC uniforms at the Olympic Games. This section provides visual illustrations regarding the placement and size of Sport Specific Implementation for any items.

SUBMISSION PROCESS

The IOC has set up a new tool for items to be reviewed and offer assistance. The new Uniform Submission tool is now live on RELAY, where uniforms can be submitted to the IOC for review.

If you are an NOC who does not have access to RELAY and needs access to submit the uniforms, please email nocnet@olympic.org

As in previous Games, while the process is not mandatory for this sport, it is still highly encouraged to submit uniform for review to minimise any possible Games-time issues. Once a submission has ben made through the IOC's online submission tool, NOCs will be notified of the "reviewed" or "noncompliant" status of their submitted items.

Identification of the Manufacturer

One Identification of the Manufacturer [clothing item will be permitted, to a maximum size of 30cm² (3 to 3.5cm below the shoulder line of the left arm.)

- Tracksuit One Identification of the Manufacturer per clothing item will be permitted, to a maximum size of 30cm².
- Belt One Identification of the Manufacturer [

Sport Equipment

 Trunk Protector | Scoring System (PSS) One Identification of the Manufacturer [permitted, to a maximum size of 30cm².

will be permitted, to a maximum size of 6cm².

- Shin guard | Arm guard | Other protective equipment One Identification of the Manufacturer per item will be permitted, not greater than 10% of the surface area of the item, to a maximum size of 14cm².
- Sensing socks One Identification of the Manufacturer [will be permitted, to a maximum size of 6cm².

Head Protector | Scoring System (PSS) Two Identifications of the Manufacturer [per item will be permitted, to a maximum size of 6cm² of each and placed above either one of the ears.

Note: Trunk Protector, Sensing socks, Head protection and Gloves are provided by the Organising Committee.

Accessories

Bag

One Identification of the Manufacturer per item will be permitted, not greater than 10% of the surface are of the item, to a maximum size of 60cm².

Shoes/Footwear

Shoes

All footwear items may carry the Identification of the Manufacturer as generally used on products sold through the retail trade during the period of 6 months or more prior to the Games.

Section 05

Third Party Identifications (athlete names) The athlete's full name(s) or family name(s) or initial of the first name and family name(s), may appear on the belt once, to a maximum size of 10cm².

No names of athletes are allowed on any other items. section 05 of the General Guidelines applies.

Section 07

NOC Emblems and National Identity

National flag/NOC emblem

On competition clothing, the national flag or NOC emblem [O] must be located on the right arm, with a size of 10cm × 7cm (3 to 3.5cm below the shoulder line of the right arm).

One IF Homologation Mark [+] will be permitted in front of the jacket where the black neck bands are met with a maximum size of 30cm².

NOC code

On competition clothing, the NOC code must be printed in black on the upper garment, using bold Verdana font, and located 5cm or higher from the lower edge of the jacket within the size of 30cm x 12cm.

Section 09 Homologation Marks

Homologation marks (CE) [�] must be located on the left side of the centre of the back of head of the PSS. in a white text colour and within a size of 4cm².
